TO ALL CONTRIBUTING CONTRACTORS

This letter provides the details of the agreement of the Pipe Line Contractors Association ("PLCA") and the United Association of Journeyman and apprentices of the Pipefitting Industry of the United States and Canada (UA) relating to fringe benefits. This letter provides the detailed breakdown of the fringes that contributing contractors are obligated to pay effective January 1, 2010. We have attached a schedule illustrating the same rates and how the health and welfare and pension rates will be reciprocated from the Pipeline Industry Benefit Fund to other local union funds. The reciprocal breakdown is informational only as the Fund office will make the proper distributions.

NOTE: The new contract starts on Friday of the work week ending January 3, 2010. The Fund office recommends that 2 (two) reports be submitted for this week. One report should show the hours worked for the first part of the partial week at the 2009 rates. The second report should show the hours worked at the new 2010 rates for the remainder of the week.
