This letter provides the detailed breakdown of the fringes that contributing contractors are obligated to pay effective May 30, 2016 to June 4, 2017. We have attached a reproduction of pages from the National Pipeline Agreement illustrating the same rates and how the health and welfare and pension rates will be reciprocated from the Pipeline Industry Benefit Fund to other local union funds.
